Historical Note: The Log Cabin Republicans (LCR) are a group of Gay, Lesbian, Bisexual, and Transgender (GLBT) people who identify with a conservative political ideology. The group befits former President Ronald Reagan’s “Big Tent” concept for the Republican Party. Members focus on shared Republican Party goals (such as individual liberty, strong national defense, and a free market economy) as they advocate GLBT rights.

The group began in response to the Briggs Initiative—an attempt to fire and ban all openly GLBT educators in California public schools—in 1977. Regional clubs organized throughout the 1980s, and the branches organized a national office in the early 1990s. The national office began partly in response to the infamous “culture wars” speech given at the 1992 Republican National Convention by Patrick Buchanan. The speech’s homophobic rhetoric spawned an urgent desire for collective political clout on the national level.

Since that time, the Log Cabin Republicans—together with the GLBT Republican think tank, the Liberty Education Forum—have supported and opposed political candidates, propositions, Supreme Court Rulings, studies, and issues, all in the pursuit of affecting positive change within and without the Republican Party.

Scope and Content: Boxes are **primarily** arranged according to **name and/or region** (i.e. “The Liberty Education Forum,” “Log Cabin Republicans-National,” “The Log Cabin Republicans of Riverside County, CA,” etc.)

Boxes are **secondarily** arranged according to **year**.

Folders **within each box** are primarily arranged according to **month**. However, some materials are arranged according to a specific **topic of interest**, or according to a **particular event**.

The arrangement accommodates a political organization that contends with “current events” and the passage of time—LCR materials are best understood in a chronological (rather than a subject-oriented) context. The collections includes such items as: board meeting minutes, membership lists, state and national election materials, printed reports, newspaper clippings, pamphlets, newsletters, correspondence, and convention itineraries.

The availability of these materials varies from year to year.
